

### **MBDA Now a Permanent Government Agency**

The Minority Business Development Act of 2021<sup>1</sup> was signed into law as a part of the Bipartisan Infrastructure and Jobs Act. It is one of the most significant pieces of legislation impacting the minority business community in the last 50 years. The passage of this historic legislation means MBDA is permanent<sup>2</sup> and will expand geographically and receive an elevated status within the Department of Commerce. This action increases MBDA's programs, outreach, and support for the Nation's more than 9 million minority-owned businesses and future entrepreneurs. Specifically, some of the Act's more impactful directives are:

- Creates a presidentially appointed, and Senate-confirmed Under Secretary of Commerce for Minority Business Development to lead the Agency.
- Increases the MBDA's grant-making capacity to partner with community and national nonprofits engaged in private and public sector development, as well as research.
- Mandates the creation of the Parren J. Mitchel Entrepreneurship Education Grants Program to cultivate the next generation of minority entrepreneurs on HBCU and MSI campuses.
- Creates a council to advise the Under Secretary on supporting MBEs.
- Authorizes the establishment of regional offices and Rural Business Centers.
- Authorizes the Under Secretary to coordinate federal MBE programs.

### Awarded \$48.6 Million in Federal Funding

In 2021, thirty-five grants were awarded totaling \$13.9 million, marking the beginning of a new 5-year cooperative agreement cycle for MBDA Business Centers, with each receiving funding between \$375,000 - \$415,000 per year. Continuing our efforts to broaden our impact with the development of innovative new programs, MBDA awarded a total of \$16.7 million for pilot programs addressing Agency priorities – Entrepreneurship Education for Formerly Incarcerated Persons; Inner-City Innovation Hubs; MBDA Enterprising Women of Color Centers; Access to Capital; and Entrepreneurship Support for Indigenous Communities entrepreneurship (American Indian, Alaska Native, Native Hawaiian, and Pacific Islanders). MBDA also distributed \$17.9 Million for Coronavirus Response and Relief.

# Office of Policy Analysis & Development Up and Running

MBDA fully operationalized its newest unit, the Office of Policy Analysis and Development (OPAD). OPAD is fulfilling the Agency's commitment to conduct data analysis, qualitative assessments, and research for and about minority business enterprises. OPAD has formed valuable partnerships with data producing agencies, economic and research entities, and policy organizations that have led to the release of new and original reports in fiscal year 2021, including The Contribution of Minority Business Enterprises to the U.S. Economy. This report looks at the current and future contributions of employer minorityowned firms to the U.S. macroeconomy and the underlying drivers impacting their contributions. A second report, Keys to Unlocking Business Development in Indian Country is an in-depth examination of economic characteristics across 166 tribes in comparison to the broader U.S. economy, including regional and rural areas. A third publication, Tribal Colleges and Universities – Reservation Entrepreneurship and Business **Development** assesses the impact Tribal Colleges and Universities with business curricula have on reservations.
